by GSA that can be used by all federal agencies in purchasing supplies and services. A Multiple Award Schedule provides you with a large selection of items and the flexibility necessary to select the Best Value item that meets your needs.

GSA's Center for Facility Maintenance and Hardware has combined all of our product line Schedules into one Schedule, number 51 V. Best Value

When determining "Best Value" you may consider the following:

- Special features of the product/services that are being offered, but not provided by a comparable product/service
- Trade-in considerations
- Probable life of the item selected compared to that of a comparable item
- Warranty considerations
- Maintenance availability
- Past performance
- Environmental and energy efficiency considerations

Scope Issues

The concept of Hardware Store program is to offer federal customers a total solution. There are three Special Item Numbers (SINs) within this department:

105-001 is the retail (Hardware Store Walk-In/Walk-Out) environment; 105-002 is the wholesale (catalog) portion; and 105-003 covers services routinely performed in a hardware store. Commercial products and services available in the Hardware Store include, but are not limited to: flooring, fencing, hardware, building material, tools, appliances, electric, paint, plumbing, lawn/garden, motors, shop, machining, welding, material handling, carts/trucks, dock equipment, HVAC, cleaning, irrigation, and related services.

When placing an order against any of the Hardware Store contracts, ordering activities should be certain the items they are ordering are routinely available in a hardware store and not outside the scope of the contract.

In the retail environment, the government purchase card directly triggers the discount. While the purchase card is the preferred method of payment, purchase orders are also accepted by all industry partners.

GSA has partnered with JWOD and industry partners to exclude essentially the same (ETS) items from contracts

awarded under this program. Most industry partners are participating as a JWOD-approved dealer which, therefore, allows the federal customer to obtain JWOD products as mandated by the Federal Acquisition Regulation at the same time. In some instances our industry partners have elected to stock JWOD items in their storefronts and/or inventory.

Trade Agreement Act

Per the Trade Agreement Act (January 2005) the following "Designated Countries" are authorized sources of material and services whose "End Products" come from:

1. World Trade Organization Government Procurement Agreement countries, including: Aruba, Austria, Belgium, Canada, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hong Kong, Hungary, Iceland, Ireland, Israel, Italy, Japan, Korea (Republic of), Latvia, Liechtenstein, Lithuania, Luxembourg, Malta, Netherlands, Norway, Poland, Portugal, Singapore, Slovak Republic, Slovenia, Spain, Sweden, Switzerland, and the United Kingdom.
2. Free Trade Agreement countries, including: Australia, Canada, Chile, Mexico, Morocco, and Singapore.
3. Least developed countries, including: Afghanistan, Angola, Bangladesh, Benin, Bhutan, Burkina Faso, Burundi, Cambodia, Cape Verde, Central African Republic, Chad, Comoros, Democratic Republic of Congo, Djibouti, East Timor, Equatorial Guinea, Eritrea, Ethiopia, Gambia, Guinea, Guinea-Bissau, Haiti, Kiribati, Laos, Lesotho, Madagascar, Malawi, Maldives, Mali, Mauritania, Mozambique, Nepal, Niger, Rwanda, Samoa, Sao Tome and Principe, Senegal, Sierra Leone, Solomon Islands, Somalia, Tanzania, Togo, Tuvalu, Uganda, Vanuatu, Yemen, or Zambia.
4. Caribbean Basin countries, including: Antigua and Barbuda, Aruba, Bahamas, Barbados, Belize, British Virgin Islands, Costa Rica, Dominica, Dominican Republic, El Salvador, Grenada, Guatemala, Guyana, Haiti, Honduras, Jamaica, Montserrat, Netherlands Antilles, Nicaragua, St. Kitts and Nevis, St. Lucia, St. Vincent and the Grenadines, and Trinidad and Tobago.



JWOD (NIB/NISH) Products

The Javits-Wagner-O'day (JWOD) program (NIB/NISH) provides many products to federal customers under its mandatory source authority. Before making any open market purchase from a Schedule contractor, ordering agencies should determine if there is a comparable JWOD (NIB/NISH) product.

SIN 834-200 Marine Commercial Coatings, Adhesives and Sealants

Includes topcoats, primers, pre-treatment products, thinners and related products designed primarily for, but not limited to, use in the manufacture, repair routing maintenance or prevention of the formation and propagation of corrosion on marine vessels, oil drilling platforms, navigational aids, component parts and structures intended for exposure to a fresh or salt water marine environment, either above or below water. Anti-seize compounds, preservatives for wood, plastics or textiles and materials to convert oxide corrosion to protective coatings. Application accessories and equipment may be included. Product may be a kit or require multi-component system application. Technical support or training that is normally provided with commercial sales of this product may be included. Products containing either lead or chromate must be prominently and properly identified and labeled.

SIN 834-300 Vehicle and industrial Commercial Coatings, Adhesives and Sealants

Includes topcoats, primers, pre-treatment products, thinners, body fillers and related products designed primarily for, but not limited to, use in the manufacture, repair, routine maintenance or prevention of the formation and propagation of corrosion on optical or electrical applications, equipment, vehicles, weapons systems and related miscellaneous parts. Anti-seize compounds, preservatives for wood, metal, plastics or textiles and materials to convert metal oxide corrosion to protective coatings. Product may be a kit or require multi-component system application. Application accessories and equipment may be included. Technical support training that is normally provided with commercial sales of this product may be included. Products containing either lead or chromate must be prominently and properly identified and labeled.

SIN 834-400 Architectural commercial Coatings, Adhesives and Sealants

Includes topcoats, sealers, fillers, primers, pre-treatment products, thinners and related products designed primarily for, but not limited to, construction, repair, marking, maintenance or prevention of the formation

and the propagation of corrosion on structural surfaces or for joining structural members, in both interior and exterior applications for either commercial or residential structures, foundations and pavements. Coatings include wood, metal, plastics or textiles, coatings and sealers for concrete or asphalt pavements and materials to convert metal oxide corrosion to protective coatings. Product may be a kit or require multi-component system application. Application accessories and equipment may be included. Products containing either lead or chromate must be prominently and properly identified and labeled.

SIN 834-500 Stains, Varnishes, Sealers, Shellacs and Lacquers

All commercial types and sizes may be offered. Low VOC-compliant products containing no ozone depleting substances or hazardous air pollutants (HAPS) are preferred. Products should be identified when resistant to moisture, salt spray, hydrocarbons or corrosives. Products containing either lead or chromate must be prominently and properly identified and labeled.

SIN 834-600 Coating Removers

All commercial types and sizes available for use on specified substrates may be offered. Low VOC, biodegradable and HAPS-compliant products containing no ozone depleting substances are preferred.

SIN 834-700 Applicators and Accessories

All commercial types and sizes available for application of paints, varnishes and other coatings. This includes, but is not limited to, brushes, mitts, sticks, rollers, roller covers, conditioners, grids and roller kits.

SIN 834-900 Petroleum and Fuel

Includes solid fuels, liquid propellants, fuels, oxidizers, both chemical and petroleum base; fuel oils, cutting, lubricating, insulating, refrigeration, penetrating, vacuum pump, tempering, metal quenching and hydraulic oils; greases, such as, automotive, graphite, ground glass joint, heat dissipation and high temperature lithium greases; miscellaneous fats and oils, such as, fish, pine, fog and storm oils; and waxes, such as sealing bone, paraffin, and ski, except for cleaning and polishing waxes.

SIN 105-001 Hardware Store Walk-In/Walk-Out

Allows customers to walk into a hardware store and, with their government Purchase Card, purchase and receive a discount at the point of sale. Equipment and tool rental normally provided to commercial customers is also included.

SIN 105-002 Hardware Store Catalog

Allows customers to place a catalog order over the phone or via the Internet. Contractors will provide catalog service and the customer will receive the lowest price or a discount off the vendors' retail prices. Equipment and tool rental normally provided to commercial customers is also included.

Commercial Coatings, Adhesives, Sealants, Fuels and Lubricants Department

SIN 834-100 Aerospace Commercial Coatings, Adhesives and Sealants

Includes topcoats, primers, film adhesives, composite repair materials, pre-treatment products, thinners and related products designed primarily for, but not limited to, use in the manufacture, repair, routine maintenance or prevention of the formation and propagation of corrosion on aircraft, helicopters, missiles or vehicles designed to travel outside earth's atmosphere. Anti-seize compounds and materials to convert oxide corrosion to protective coatings. Product may be a kit or require multi-component system application. Application accessories and equipment may be included. Technical support or training that is normally provided with commercial sales of this product may be included. Products containing either lead or chromate must be prominently and properly identified and labeled.



SIN 834-99 New Technology

Includes new technology in the fields of adhesives, sealants, corrosion preventatives, or preservatives.

Appliance Department

SIN 639-001 Domestic

Includes commercially available products and accessories from appliance vendors to include, but not limited to, refrigerators, freezers, microwaves, ranges, clothes washers, clothes dryers, laundry centers, dishwashers, window, wall, ceiling air conditioners, portable air conditioners, water coolers, drinking water dispensers, air purifiers, circulating and ceiling fans, evaporative air coolers, and combination appliances, etc. (Note: these items could be shipped overseas also, but cannot be listed under more than one SIN.)

SIN 639-002 Export

Includes commercially available products and accessories from appliance vendors, to include, but not limited to, refrigerators, freezers, microwaves, ranges, clothes washers, clothes dryers, laundry centers, dishwashers, window, wall, ceiling air conditioners, portable air conditioners, water coolers, drinking water dispensers, air purifiers, circulating and ceiling fans, evaporative air coolers, and combination appliances, etc. (Note: these items cannot be listed under more than one SIN.)

SIN 639-003 Services

Ancillary services such as, but not limited to, extended warranties, and installation and removal of replaced products, leasing, rental and trade-ins.

SIN 616-001 Ancillary Services

Lawn and Garden Equipment Department

SIN 341-001 Mowers

Includes, but not limited to, walk-behind gas, diesel, electric, rechargeable and self-propelled, slope, reel, and riding, etc.

SIN 341-200 Tractor Drawn or Mounted Mowing Implements

Includes, but not limited to, tractor mounted rotary mowing units, flail mowing units, boom mowers and sickle mowers.

SIN 341-300 Gas or Diesel Tractors

Without mowing implements, two-wheel drive and four-wheel drive, specifically lawn and garden dedicated. (EXCLUDES tractors with attachments enabling multiple or general purpose use such as loading, excavation, agricultural, highway/road maintenance or clearing, mowing construction, etc.)

SIN 341-400 Various Lawn and Garden Implements

Includes, but not limited to, roto tillers, snow throwers, blowers, trimmers (grass/hedge/tree), edgers, blowers/vacuums/sweepers, sprayers, renovators, spikers, sod cutters, and broadcasters/ spreaders/ seeders, etc.

SIN 341-500 Cattle Guards

SIN 341-600 Chainsaws

SIN 341-700 Accessories/Replacement Parts

SIN 341-800 Lawn and Garden Hand Tools

SIN 341-99 Introduction of New Products

Woodworking and Metalworking Department

SIN 577-001 Woodworking Machinery and Equipment

Includes, but is not limited to, lathes, sanders, sawing equipment (circular, band, radial arm, mitering, table and panel cutting), and shaping and surfacing machinery.

SIN 577-005 Metalworking Machinery and Equipment

Includes, but is not limited to, milling machines, engraving machines, arc/wire/heli-arc welders, gas welding and cutting equipment, hydraulic presses, press

brakes, shears, drill presses, grinders, engine lathes, and metal sawing equipment, etc.

SIN 577-099 Introduction of New Products/ Services for Woodworking and Metalworking Machinery and Equipment

SIN 577-002 Maintenance of Woodworking/ Metalworking Machinery and Equipment

SIN 577-003 Accessories/Services for Woodworking and Metalworking Machinery and Equipment
