1.0 Introduction and Quick Start / FAQs

- What is 2GIT?
 - 2GIT is the Second Generation Information Technology Solutions blanket purchase agreements (BPAs) designated as Best-in-Class (BIC).
- What IT products can I buy from 2GIT?
 - 2GIT is an efficient way to purchase commercial off-the-shelf IT hardware and software products and ancillary supplies and services (as described in "Products List" on page 5 below and in Table 1).
- Who can buy from 2GIT?
 - 2GIT is available for use government wide (DoD and use by other federal, state, local and tribal governments through the GSA Cooperative Purchasing Program).

- Benefits of using 2GIT?

 - **Competitive pricing, pre-competed** IT hardware and software through GSA'sspecial item numbers (SINs) (reference scope, SINs, Table 1).
 - **Maximum product availability** with access to more authorized industry partners and resellers -- new products added quickly and regularly.
 - Improved cybersecurity and supply chain risk management (SCRM) protection, integrated supply chain risk management.
 - Meet small business, socio-economic goals.

2GIT Ordering Guide

The 2GIT Blanket Purchase Agreements (BPAs) were competitively awarded by GSA, in accordance with Federal Acquisition Regulation (FAR) 8.405-3, to provide ordering activities with 2GIT offerings at discounted prices and to facilitate the following:

Product Pricing – BPA holders were required to provide detailed pricing for explicitly defined, standardized products, so customers can easily compare pricing for a single product across BPA holders. Additional discounts may also be obtained at the delivery order level.

Standardized Requirements – BPA holders are required to meet standardized technical and security requirements incorporated in the 2GIT BPA contract.

Comprehensive Solution from a Single Delivery Order – Customers can obtain 2GIT, IT Products and support/ancillary services using a single, fixed-price delivery order.

Proven Acquisition Excellence – 2GIT BPAs will be administered using GSA's proven acquisition processes to ensure compliance and efficiency. 2GIT BPA holders reporting requirements have already been established to make it easy for BPA users.

Summary of Benefits: The benefits extend to all of GSA's customers as the BPAs will be available government-wide and include:

- Better pricing
- Improved Supply Chain Risk Management (SCRM)
- Increased availability of products for major OEMs
 - \circ Faster contract modifications
 - Full spectrum of hardware/software products
- Freed up program and acquisition resources

Synopsis: The GSA established multiple BPAs for 2GIT offerings as a government-wide IT Products solution and replacement for Air Force's Netcents-2 IT products contract.

The 2GIT BPAs were awarded competitively against GSA Multiple Award Schedule (MAS) contracts. It is the responsibility of the ordering activity contracting officer to ensure compliance with all applicable fiscal laws prior to issuing an order under the BPA, and to ensure that the selected BPA holder provides the best value for the requirement being ordered.

Funds obligation: No funds are obligated on the 2GIT BPAs. Funds will be obligated on the Delivery Orders issued by ordering activities.

Authorized BPA Users: Orders may be placed under this BPA by sources identified under GSA Order, ADM 4800.2G, *Eligibility to Use GSA Sources of Supply and Services* (Eligibility to Use GSA

Sources of Supply and Services), dated 16 FEB 2011, provides detailed information regarding the agencies and organizations that are eligible to use GSA sources), United States Federal agencies, Department of Defense (DoD) components, State, Local, and Tribal Governments, and cost-reimbursement Contractors authorized to order in accordance with FAR Part 51. For the purposes of this agreement, a DoD component is defined as: the Office of the Secretary of Defense (OSD), the Military Departments, the Chairman of the Joint Chiefs of Staff, the Combatant Commands, the Inspector General of the Department of Defense (DoD IG), the Defense Agencies, the DoD Field Activities, the U.S. Coast Guard, and the Intelligence Community. GSA or other applicable ordering organizations/agencies are authorized to place orders under this BPA on behalf of DoD end users and must comply with Defense Federal Acquisition Regulation Supplement (DFARS) 208.7400.

Award Date: 2/18/2021

2GIT Ordering Period: from 3/31/2021 through 3/30/2026

Note that any order issued (including its order options) against an existing BPA before the BPA expires will have its own Period of Performance (including order options). It shall be completed (including any order options) according to the Schedule Contract FAR clause 52.216-22(d).

The fundamental scope of the 2GIT BPAs is to provide a total solution one-stop-shop in the information technology market to meet the needs of the Air Force, Department of Defense (DoD) agencies, and other federal, state, local, regional, and tribal governments. The 2GIT BPAs provide the following categories of products and associated services worldwide: networking equipment, servers/storage/peripherals/multimedia, identity management/biometric hardware, end user devices, and associated Commercial Off the Shelf (COTS) software not included on other DoD or Federal Agency enterprise license agreements. The 2GIT BPAs provide a streamlined process for procuring IT hardware and software commodities, ancillary supplies and installation services. The types of IT products that are available through the 2GIT BPAs are included in following Special Item Numbers (SINs) and described further in the Table 1 following:

Additional 2GIT information:

The Federal Acquisition Regulation (FAR) provides the primary regulatory guidance for the GSA Schedules program. The General Services Acquisition Regulation (GSAR) is the GSA FAR supplement. The GSAR provides guidance tailored to GSA acquisitions, including GSA Schedules contracting. GSAR guidance primarily affects GSA Schedules by providing supplementary guidance to the Contracting Officers awarding and administering GSA Schedule contracts.

FAR Subpart 8.4, Federal Supply Schedules, prescribes procedures that Federal Government ordering activities must follow when issuing orders against GSA Schedules.

Orders placed following these procedures are considered to be competitive (See FAR Subpart 8.404(a)). FAR Part 12, Acquisition of Commercial Items, prescribes policies and procedures unique to the acquisition of commercial items. It implements the Federal Government's preference for the

acquisition of commercial items contained in Title VIII of the Federal Acquisition Streamlining Act of 1994 (Public Law 103-355) by establishing acquisition policies more closely resembling those of the commercial marketplace and encouraging the acquisition of commercial items and components.

FAR Subpart 6.102(d)(3), Competition Requirements, pertains to the use of competitive procedures. It states use of MAS issued under the procedures established by the Administrator of General Services consistent with the requirement of 41 U.S.C. 259(b)(3)(A) for the MAS program of the General Services Administration is a competitive procedure.

The primary regulatory guidance is provided by the Federal Acquisition Regulation (FAR): FAR Subpart 8.4, Federal Supply Schedules, prescribes procedures that Federal Government ordering activities must follow when issuing orders against GSA Schedules. Awards made following these procedures are considered competitive. The General Services Acquisition Regulation (GSAR) is the GSA FAR supplement and is a subset of the General Services Acquisition Manual (GSAM). GSAR provides guidance tailored to GSA acquisitions, including GSA Schedules contracting. GSAR guidance primarily affects GSA Schedules by providing supplementary guidance to the contracting activities that are awarding and administering GSA Schedule contracts. All GSA Schedule contracts are awarded using FAR Part 12, Acquisition of Commercial Items.

Any agency utilizing GSA Schedules must use the procedures described in FAR Subpart 8.4. Some agencies issue supplementary guidance to the FAR. For example, the DoD has the Defense Federal Acquisition Regulation Supplement (DFARS); the Army has the Army Federal Acquisition Regulation Supplement (AFARS) in addition to the DFARS; and NASA has the NASA FAR Supplement (NFS). The competition requirements for civilian agencies and DoD are the same. The one exception is the DoD requires the Contracting Officer to consider additional steps when only one response is received to a competitive solicitation over the SAT. 8 | Multiple Award Schedules Training Notes: Acquisition planning is required for all acquisitions over the micro-purchase threshold, which is currently \$10,000. FedBizOpps (now on beta.SAM.gov) notice is only required post-award for a limited sources acquisition. Responsibility determinations are made by GSA, at the contract level. Terms and conditions are already set in the Schedule contracts. Fair and reasonable pricing has already been determined in the Schedules, though over the SAT, agencies must request price reductions.

2.0 Considerations and Steps to Order from 2GIT BPAs (you may go direct to Section 4.0 Ordering 2GIT Products and Placing Requests for Quote)

2.1 Scope Determination - Establish Ordering Activity Requirements. Can 2GIT meet your needs?

Can 2GIT meet your IT needs? Are your requirements in the scope of 2GIT offerings? 2GIT meets a wide scope of commercial off the shelf IT hardware, software and ancillary services needs. To see if a 2GIT BPA is appropriate it can meet your needs please refer to Table 1, or contact us at ITCSC@gsa.gov or call (855) 482-4348.

2.2 *RFQs* requiring ancillary services, Statement of Work (SOW), for ancillary services only: Ancillary Services are directly associated with delivery of the IT product solution and are not stand alone services. Prepare a statement of work (SOW) only if required for ancillary services. Ancillary service can only be purchased in conjunction with the purchase of products under the <u>2GIT BPA</u>. Ancillary Services cannot be purchased as standalone items and must be included in a configured product purchase, listed via the GSA Advantage Options/Accessories configurator. Ancillary services include training, installation, integration coincident with delivery of theproduct. For template, please visit www.gsa.gov/2GIT.

2.3 Considerations for Preparing a Request for Quote (RFQ)

Ordering under these BPAs is decentralized. Follow your agency's procedures for preparing an RFQ and follow any internal policy and procedure related to acquiring IT services.

Consider the following topics:

Delivery Order Value & Funding Type

Estimate the value of the order. Follow agency procedures for funding.

Evaluation Criteria

In crafting best value evaluation factors, consider including some combination of technical capability, price, and past performance. All orders will be fixed price.

2.4 Issue RFQ (you can go to Section 4.0 for step-by-step instructions using Advantage! or eBuy)

FAR 8.405-3(c), *Ordering from BPAs,* and FAR 8.405-3(c)(2), *Multiple-award BPAs,* apply in concert with the ordering activity's specific rules, regulations, policies and procedures, as follows:

FAR Guidance for Ordering from BPAs. The procedures in FAR 8.405-3(c) are required for BPAs established after May 16, 2011.

Multiple-award BPAs.

(i) Orders at or below the micro-purchase threshold. The ordering activity may place orders at or below the micro-purchase threshold with any 2GIT BPA holder that can meet the agency needs. The ordering activity should attempt to distribute any such orders among the 2GIT BPA holders.

(ii) Orders exceeding the micro-purchase threshold, but not exceeding the simplified acquisition threshold. The ordering activity must provide each multiple-award 2GIT BPA holder a fair opportunity to be considered for each order exceeding the micro-purchase threshold, but not exceeding the simplified acquisition threshold unless one of the exceptions at 8.405-6(a)(1)(i) applies.

(iii) Orders exceeding the simplified acquisition threshold (In accordance with FAR and Agency Policy).

Unless a small business set aside and unless a justification is prepared and approved in accordance with FAR 8.405-6, the ordering activity shall—

(1) Provide an RFQ to all 2GIT BPA holders offering the required supplies or services under the multiple-award 2GIT BPAs, to include a description of the supplies to be delivered or the services to be performed and the basis upon which the selection will be made;

(2) Afford all 2GIT BPA holders responding to the RFQ an opportunity to submit a quote;(3) Fairly consider all responses received and make award in accordance with the selection procedures.

Small Business Set Aside: For orders exceeding the micro-purchase threshold, ordering activities should give preference to the items of small business concerns when two or more items at the same delivered price will satisfy the requirement. Ordering activity contracting officers may, at their discretion set aside orders for any of the small business concerns. Follow the ordering procedures for Federal Supply Schedules at <u>8.405-1</u>, <u>8.405-2</u>, and <u>8.405-3</u>. Small business set asides may conveniently be done by creating requests for quote (RFQ) via eBuy as explained in section 4.0 of this ordering guide.

Ordering activity is encouraged to compete all orders, if time permits, to ensure pricing at or below the BPA catalog price.

Product Availability on Catalog:

Need a product that does not seem to be available on a BPA holder's catalog? IT products may be added to the catalog and ordering activities are encouraged to issue an RFI/RFQ to BPA holders so they may conveniently add needed products to catalog via contract mod (please allow sufficient time for vendors to issue the mod).

2.5 Evaluate RFQ Responses

After the RFQ Close Date, evaluate all responses received using the evaluation criteria specified in the RFQ [see FAR 8.405-2(d) for additional guidance on this topic] and select the BPA holder that represents the best value.

Price Reductions

Ordering activities shall seek a price reduction when the Order exceeds the simplified acquisition threshold (currently \$250,000).

2.6 Award Delivery Order

Place the order as you would for any other fixed-price MAS delivery order in accordance with FAR 8.406-1, *Order placement*.

Documentation

In accordance with the BPA and FAR 8.405-2(e), ordering activities will document the following:

- □ Note the BPA holder receiving the Delivery Order & all BPA holders considered
- Description of what was purchased and agreed upon pricing
- □ The evaluation methodology used in selecting the BPA holder to receive the Delivery Order
- □ The rationale for any tradeoffs in making the selection
- □ The price reasonableness determination required by FAR 8.405-2(d)
- □ The rationale for using other than a performance-based order

□ Make sure that the BPA number, the BPA holder's name, and Schedule Contract Number are included on all orders. Refer to FAR 8.406-1 for information to be included on orders.

 Getting Started: The first step in the RFQ process is to search for sources. eBuy has several ways for you to accomplish that search. The most popular is to do a keyword search. Keywords search against the titles and descriptions of schedules, SINs, and other vehicles. Another option is to browse by category. We have grouped solutions into some main categories, and browsing will let users navigate from general to specific. Finally, one can browse acquisition programs as a whole, such as Multiple Award Schedules, or technology contracts.


