Work Week: Sunday – Saturday

Overtime Rate(s):

For SCA covered employees OT rate 1.5x the normal hourly rate in excess of 40 hours per week. No double-time rate.

For professionals (physicians and physicists) - straight pay, no overtime.

Holiday Rate(s):

For SCA covered employees Holiday rate of 1.5x the normal hourly rate in excess of 40 hours in a work week. The normal hourly rate applies if less than 40-hour work week.

For Professionals (physicians and physicist), straight pay, no overtime/holiday.



On-Call / Call Back Rates:

For Physicians & Physicists

On Call Weeknight/ Weekend

A one-time flat charge for a 15.5 hour period - generally 4:30 pm – 8:00 am. Required to carry a cellphone or pager and must be able to provide consultation relative to their specialty. Physician must be within a 30 minute or 30 mile radius from the facility.

Call Back

The regular hourly rate to be charged once the provider is on site and sees patients for all hours worked. 1 minimum charge applies for call-back.

For All SCA Covered Employees

On Call Weeknight/Weekend

\$5.00 per hour. Provider must carry a cell phone or beeper and remain within 30-minute or 30-mile radius of the facility or per ordering facility requirements. Phone consultation relative to their specialty is included.

Call Back

Normal hourly rate applies if less than 40 hours worked. In excess of 40 hours overtime of 1.3x the normal hourly rate applies for each hour worked when called back and physically on site. One (1) hour minimum charge applies for call-back.
