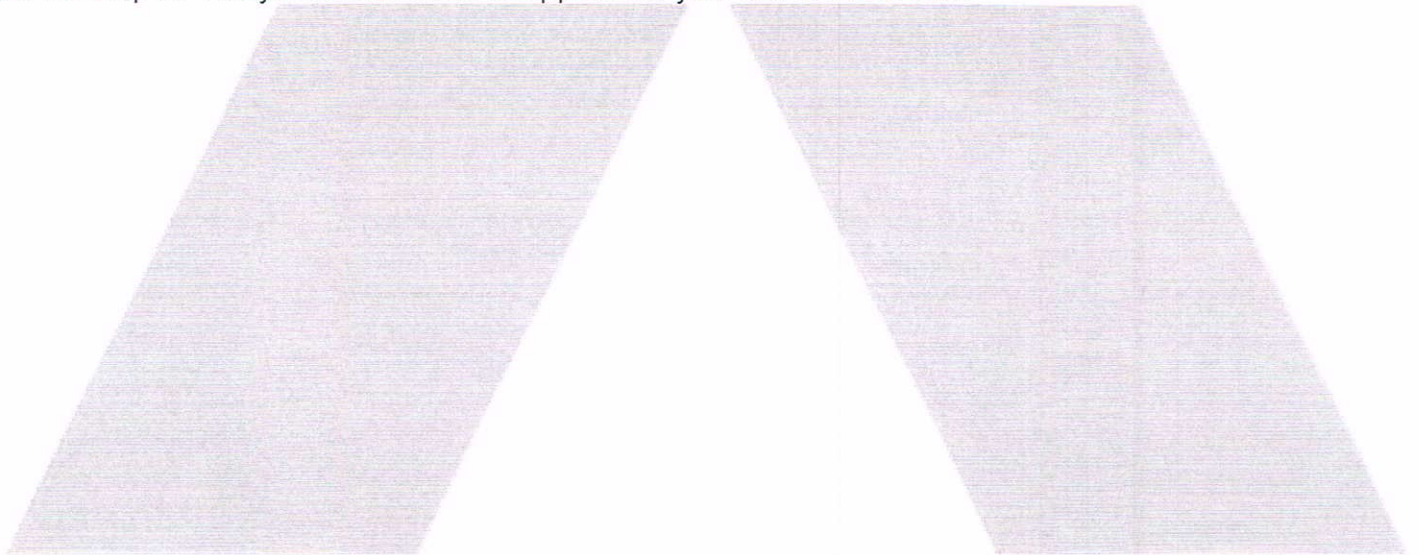
Anodyne Return Policy

All orders are shipped with a pre-paid UPS return label in the box, so returning them is easy. If a shipping error occurs due to contractor error the contractor will pay freight both ways for return/exchange of goods.

Return Instructions

1. Fill out the return form (located on the packing slip) and when applicable, a lab rework form
2. Place shoes in a protective outer box
3. Write down the tracking number for your records
4. Attach the pre-paid UPS return label to your package
5. Drop off the package at any UPS authorized location or give to your UPS driver

Once we have received your returned product(s), we will process them immediately. Please note it can take up to 5 days for the credit to appear on your bank statement.

Anodyne VA Warranty Statement

Anodyne Warranty supplements FAR 52.212-4(o)&(p)

52.212-4 (o) (TAILORED)

Warranty: The Contractor warrants and implies that the items delivered hereunder are

merchantable and fit for use for the particular purpose described in this contract. In the event that the terms of the contractor's standard commercial warranty conflict with the warranty terms contained in this clause, the terms of this clause will govern this contract, unless some other resolution is specified in the award document.

52.212-4 (p) (TAILORED)

Limitation of liability: Except as otherwise provided by an express warranty, the contractor will not be liable to the Government in a breach of warranty action for consequential damages resulting from any defect or deficiencies in accepted items. In the event that the terms of the contractor's standard commercial warranty/limitation of liability clause(s) place greater limits on the contractor's liability than do the terms contained in this clause, the terms of this clause will govern the contract.

Anodyne unconditionally accepts returns of any undamaged Anodyne shoes within six months of the shoes being inspected and accepted. (the "Warranty Period"). If provider determines that a pair of shoes does not properly work for their patient within the six months of the shoes being accepted Anodyne will exchange them at no charge for a shoe that works more appropriately for the patient. After the six-month return period, Anodyne shoes returned in an as-purchased condition may be exchanged for credit at the sole discretion of Anodyne. All shoes that are returned must be in their original packaging in order for Retailer to receive a credit.
