Senior IT Auditors shall have a Bachelor's Degree in computer science, accounting, or business administration from a fully accredited university or college. They may also have advanced professional education in the field of IT auditing. A CPA certificate, a CISA certificate, or a CDP may be substituted for 2 years of the needed education or two years of the needed experience. Senior IT Auditors shall have 7 years of experience in auditing and/ or computer programming/systems analysis, including not less than 5 years of experience in IT auditing. At least one year of this experience shall be as a senior IT auditor of IT financial application systems. Senior IT Auditors supervise, direct, and participate in the efforts of staff auditors in completing agreed-upon assignment plans. They also supervise staff auditors and review work papers prepared during assignments to ensure proper documentation. Senior IT Auditors summarize the results of assignments for the IT project manager.
