## SHIPPING & RETURN POLICY

**Shipping Policy:** Approximately 95% of our incoming (from customers) and outgoing (to distributors for drop ship) orders go through EDI systems. This allows us to process the vast majority of our customer's orders and send them to our distributors in under 90 minutes. More than half of the orders that are received before 1:00pm Mountain Time ship the same day. We also ship from more than 15 distribution centers (depending on product line). By shipping from the closest possible distribution center, we deliver most orders within 2 business days.

**Return Policy:** Access Products, Inc. (API) allows the Government to return items in the original packaging and in saleable condition within 30 days of delivery. API will provide a full refund, less any applicable restocking fee, for such item within 30 days of receipt of the returned item.

**Restocking Fees:** API may assess a restocking fee of up to 10 percent of the item cost due to customer ordering error. No restocking fees are assessed when the item is returned due to a nonconforming item or shipping error.
