Service	Detailed Description
Pest Control for Roaches (Monthly or Quarterly)	Treat all cracks & trim, inside kitchen & bathroom cabinets (if cabinets are emptied) under sinks, door and door jams, interior of closets & shelving, Underneath stove, refrigerator, dishwasher windows, window seals & blinds.
Bed Bug Heat Treatment	We perform a heat remediation treatment which is heating structure up to 135 degrees for 4 hours. This is for a 2000 sq. ft structure. We use heaters and fans with temperature monitors throughout the structure.
Roach Treatment Restaurant	Treatment is performed in cracks and trim, drain areas, underneath of tables and chairs, bathrooms, under sinks area, trash carts, under cook areas and appliances.
Wildlife Trapping (3 traps)	Known areas of animal's live traps are baited and monitored daily

Bed Bug Climb Ups Small	Climb-up Insect Interceptors are a unique and easy-to-use monitoring system to aid in the early detection of bed bug infestations. These specially designed plastic cups are pesticide-free and are coated with a thin layer of talc which makes them too slick for the bugs to crawl out.
