Social Security Number Verification

Social security numbers are verified by using the Social security administrations information and the credit bureaus information to confirm the numbers. We also use a wide variety of public data sources. This information is used primarily to search for all addresses where the applicant has lived, so that criminal records can be searched. It is an extremely valuable tool in cases where applicants have not told employers about other jobs or residences. We find people with criminal records try to move away from their criminal or civil histories hoping employers will not going looking into the past residential areas. Many criminal records are discovered this way. This search also lists name variations, aliases, or AKA names the person has used with this Social security number. Liberty Alliance uses this product known as our SSN trace. The number is obtained from public sources which may include the following; drivers licenses, driving records, firearm permits, postal service records, land titles and deeds, law enforcement records, occupational licenses, court records, political contributions, master death indexes, Security and Exchange commission, property tax records and voters registrations. This information is returned to you instantly. Your criminal and civil searches are automatically pre populated for you based on the SSN tracing. This takes the guesswork out of where you should search. You also have the ability to remove the pre-determined searches if you do not wish them to be done.

Sex Offender Register

A sex offender is typically an individual who has been convicted of a violent sex crime such as rape, or someone who has committed a sexual offense against a child or other person. Details in the report usually include identifiers, registered address, aliases, case numbers, charge(s), conviction details and period of incarceration. We cover all 50 states and include color photographs for comparison to your applicant when available. This is an instant result search, which takes about 30 seconds.

Employment Verification

Past employment verifications are done by our in-house staff at Liberty Alliance. We contact each past employer to obtain the information you request. Civil Record Search

The report will contain court cases located, dispositions of each case, and who prevailed in the case. Liberty Alliance has an average turnaround time of 33 hours or about a day and a half from submission. Some jurisdictions take longer and you will be notified of any delay via our automated system automatically. Criminal History Search

Our court researchers go to the courts and conduct "hands on" research for requested information. The report they compile and submit is Fair Credit Reporting Act (FCRA) compliant. The report will contain court cases located, dispositions of each case, fines, levels of conviction (felony or misdemeanor), terms of probation and understandable descriptions of the specific code violations. The report is compiled in chronological order of conviction for each jurisdiction searched. The report will be reviewed to ensure FCRA compliance. National Criminal Database Search

This search goes "an inch deep by a mile wide" to determine if the applicant has committed a crime. This multiple state database search takes information from departments of corrections, county jails, automated court records, Federal Bureau of Prisons and other sources from across the nation and creates a criminal history of over 170 million records. This is a broad search, which uncovers possible crimes missed by traditional searches. By combining both county criminal and the National Criminal Database Search, we are screening the widest, most accurate criminal review of an

applicant in a cost effective manner. The most effective way is to combine this with a county search to ensure the person located is in fact the subject you want screened and maintain FCRA compliance.

Statewide Searches

This search can be performed and returned instantly. Each Statewide search contains felony convictions, if any. In addition to felony convictions, some databases contain misdemeanor dispositions and/or traffic violations. Databases vary as to the beginning date of the data contained therein; some date back several decades, others date back to the early 1990s. In general, search results from these databases show name, date of birth, race, sex, offense, disposition, date of disposition, county and case number. Because these databases are updated monthly, quarterly and sometimes yearly, they should not be used in place of a county level search, with an instant turnaround.

Motor Vehicle Search

Liberty Alliance covers driving records checks in all 50 states. These reports can include records of driving while intoxicated, revoked license, accidents and minor traffic violations. Because driving records are held in state bureaus and have access to all counties in the state and sometimes-other states, they can be very useful for general screening purposes. Unless otherwise specified and an additional fee is paid, records are only searched back three years.

Federal Searches

Some offenses are violations of Federal law as opposed to state or local law. Record of these crimes can be located in the US District Courts. Each state has at least one US District Court, while others are divided into as many as four districts in separate geographical regions. Our researchers will check the federal courts to locate and review the cases for your report. Federal violations will generally not appear in either a county or statewide criminal check. Only a small percentage of criminal cases are violations of Federal law; however, Federal offenses can be very severe involving kidnapping, drug trafficking, interstate transportation of stolen goods, bank robbery and embezzlement. Unless otherwise specified and an additional fee is paid, records are only searched back seven years.
