BEHAVIORAL AND MENTAL HEALTH

Transitional Drug Abuse Treatment is developed to address referred clients from various referral sources such as the criminal justice system that provides for outpatient substance abuse treatment. Sex offender counseling utilizes evidence-based practices to address cognitive distortions in clients and to proceed through a rehabilitative process to identify their offense cycle, thinking errors, and prepare for relapse prevention.

Residential Recovery and Re-entry services are directed towards individuals who have been released from institutional custody and are in need of halfway house type of services. This service assists them in re-integrating into the community while receiving the support and interventions that are needed for success post-incarceration. Per diem rates are similarly based on the Housing Services listed below.
