2. **Exceptions to Solicitation:** The office Desk, LTD, dba Massive Toners. does not take any exceptions to any of the terms and conditions of the cited solicitation.
3. **Pricing:** The office Desk, LTD, dba Massive Toners. agrees to grant the Government the following pricing that is inclusive of the IFF: Please see attached Final Proposed Pricing.
4. **Dollar Discount:** The office Desk, LTD, dba Massive Toners. is offering the Government the following discounts:
 - Basic Discount: 4%
 - Volume Discount: 1% @ \$10,000.00 to \$29,999.00
2% @ \$30,000.00 to \$49,999.00
3% @ \$50,000 and up
 - Prompt Payment Discount: None
 - Credit Card Discount: Not Applicable
 - Other Discounts: Not Applicable
5. **Industrial Funding Fee (IFF):** The office Desk, LTD, dba Massive Toners. understands the application of the IFF (as outlined in clause 552.238-74 – IFF and Sales Reporting) and understands how it will be included in the contract total sales.

6. **Delivery Terms:** FOB Destination –Normal Delivery: 2 Days; Expedited Delivery: 1 Days
7. **Identification of the Most Favored Customer:** The office Desk, LTD, dba Massive Toners. has identified "Hamaspik of Rockland" as their Most Favored Customer(s).

13. **Inappropriate Use:** The office Desk, LTD, dba Massive Toners. understands that this contract shall only be used for the products/supplies (also include the word "Services", if applicable) listed in the above referenced solicitation and that inappropriate use of the contract for other than what is within scope of this schedule may subject them to penalties provided by statute and regulation.
14. **Return Goods Policy:** Returns must be pre-authorized within 60 days of invoice date. Goods returned must be suitable for resale and in original packaging. Discontinued items are not returnable.
15. **Empty Toner Policy:** Per Manufacturer
16. **Warranty Information:** Warrants all items to be free of defects in material and workmanship. Specific items carry particular manufactures' warranties, and all manufacturers' warranties and guarantees are honored.
17. **Participation in the Disaster Recovery Program: Yes**
