1. All vinyl coated and hot dipped galvanized products are covered by a 5 year limited warranty. After one year the above warranty will be prorated as follows:

Year 2 replacement parts/products will be provided at a discount of 80% off current retail value
Year 3 replacement parts/products will be provided at a discount of 60% off current retail value
Year 4 replacement parts/products will be provided at a discount of 40% off current retail value
Year 5 replacement parts/products will be provided at a discount of 20% off current retail value
 2. Most powder-coated products are covered by a one-year limited warranty. *Direct bury frames (extended into ground) are not covered by this warranty.*
 3. Freight charges to return defective parts to Diversified, or to ship replacement parts/products to the customer, costs associated with disassembly, re-assembly, and disposal of materials, are the responsibility of the customer.
 4. Damage from vandalism, abnormal use, incorrect installation, freight company negligence, or lack of maintenance is not covered by this warranty.
