Process begins with NEXCUT generating unique adhesive bar codes along with a manifest documenting types of devices and serial codes. Upon arrival, NEXCUT's bonded field technicians scan your drives which automatically references the manifest. After 100% validation, equipment is ready for complete unrecoverable destruction.

### Secure Destruction and Recycling:

After validation, media conveys into auto locking containers which couple with a hydraulic curbside bin lifter to meter devices into the shred hopper. Metal is ground to bits and the entire procedure can be viewed on a side mounted LCD screen. NEXCUT mobile shredding equipment is custom designed in accordance with local, state and federal legislation and leads the industry in particle size and throughput. NEXCUT adheres to a zero landfill policy whereby electronics are domestically recycled by R-2 and e-Stewards certified downstream partners.

NEXCUT can shred pretty much everything. Over the years we've destroyed luggage, purses, perfume bottles, mascots, food pouches, phone cards, designer jeans ... you name it.

### NEXCUT SECURE DESTRUCTION SERVICES

NEXCUT is proudly NAID AAA Certified since 2008.

The National Association for Information Destruction (NAID) defines shredding industry best practices. NAID is our Secure Destruction Industry trade group. It lobbies Congress for privacy legislation and ID theft prevention, maintains an active register of shredding companies, and hosts an online marketplace for providers. But NAID's most important contribution is arguably its AAA Certification program.

AAA Certified means that a shredding company complies with security criteria contained in HIPAA, FACTA, GLB and State specific privacy laws. NAID verifies employee background screening, equipment integrity, guarded facility access, shred particle size, recycling chain of custody, etc. AAA companies pass rigorous random audits where an outside security contractor basically shines a flashlight on your entire business.

The criteria to becoming AAA-NAID-certified involves:

Employee Hiring and Screening (Includes Temporary and Outsourced Employees)

- Employees sign a confidentiality agreement
- Drivers meet all licensing requirements of the governmental jurisdiction (State for USA companies)
- Employees produce some sort of law enforcement clearance, which is kept on file. There is also a sevenyear employment history on file.
- Employees are drug-screened at the time of hiring. If there is any local law, which supersedes this requirement, copy of the law must be provided. Employees are also subject to random drug screening.
- Employee credit reports are a part of the employee file before they have reached the set probationary period of not more than 30 days. If there is any local law, which supersedes this requirement, copy of the law must be provided.

### **Operational Security**

- Materials are always attended by a company employee or physically secured from unauthorized access while in the custody of the destruction contractor before they are destroyed.
- All materials are contained during removal from customer to destruction vehicle to prevent loss from wind or other atmospheric conditions.
- The firm has written policies and procedures for drivers and processing employees.
- Drivers and helpers wear a specific uniform to aid in their identity (minimum of a company shirt) and wear
  picture ID badges.

### The Destruction Process

- All trucks will have the applicable government inspection for roadworthiness on file. (Must be Claimed for AAA certification)
- All trucks will have lockable/securable cabs and lockable/securable fully enclosed boxes.
- Paper is destroyed by equipment that reduces the prominent percentage (over 90%) of the paper to
  particle size that fits the following specifications with no percentage being appreciably larger than the
  following specifications.
- Mobile shredding is performed by a Pierce and Tear shredder. Maximum width of shredded paper is 3/4 inch wide by 2 1/2 inches long.
