### **RETURN MERCHANDISE AUTHORIZATION POLICY**

Return requests must be approved, processed, and returned to our distribution center within 30 days of the original invoice date. **For returns over 30 days, every effort will be made accommodate the return. There will be a 15% re-stocking fee.**

If the return was necessitated by our shipping mistake we will pay for the return freight, otherwise freight is the customer's responsibility.

Credit can take up to 10 to 15 days, after merchandise is returned, to be applied to the customer's account. This insures time for the merchandise to be received back to the warehouse and placed back in stock. If an item is returned back to the warehouse in unusable condition, the return credit will not be issued.
