Restroom Odor Counteractant

Most unpleasant, unsanitary odors in restrooms come from the fixtures; the urinals and toilets. The AeroWest system drips an odor counteractant and cleaning detergent fluid directly into each fixture killing urine and fecal odors at the source leaving a light fragrance in the restroom and eliminating the need for air fresheners, screen blocks etc. To insure the correct working of the AeroWest system, a service representative checks, adjusts, cleans and fills the dispensers every four weeks.

The Odo-San fluid is dispensed into each toilet and urinal killing urine and fecal odors at the source leaving a light fragrance in the area, preventing the deposition of scale on the porcelain surfaces and keeping the fixtures sanitary. To insure the correct working of the Odo-San system, a service representative checks, adjusts, cleans and fills the dispensers every four weeks.
