All Mohawk lifts incorporate **all position mechanical safety locks** in both columns, **infinite position hydraulic safeties**, truck adaptors as standard equipment, **a full 5-year warranty**, and **lifetime cylinder warranty**.

Mohawk columns are constructed of 3/4" thick "C" shaped forklift mast sections. All Mohawk carriages ride on 16 double sealed self-lubricating steel ball bearing rollers (not plastic slide blocks). These design features give the Mohawk lift an infinitely longer life cycle than other lifts and make Mohawk lifts the heaviest built lifts in the industry.
