#### PROGRAM MANAGER

Serves as the contractor's contract manager, and shall be the contractor's authorized interface with the Government Contracting Officer, the Contracting Officer's Representative, government management personnel, and customer agency representatives. Responsible for formulating and enforcing work standards, assigning contractor schedules, reviewing work discrepancies, supervising contractor personnel, and communicating policies and goals of the organization to subordinates. Responsible for overall contract performance.

Required Experience

A minimum of 10 years of experience in environmental project management is required.

Required Education

A BS/BA degree is required.

#### SENIOR PROJECT MANAGER

Provides management and technical direction to project staff. Exercises independent judgment as well as a high level of analytical skills for solving complex technical and management problems. Plans, directs, and manages the technical and administrative activities of assigned projects to ensure that the goals and objectives of project are completed within schedule and budget.



Required Experience

A minimum of 5 years of experience is required. Experience should include work planning, control of budget, schedule management, contract and subcontract management, and personnel management, supervision, and regulatory compliance.

Required Education

A BS/BA or equivalent experience is required.

#### **PROJECT MANAGER**

Responsible for project performance. Provides direction to project-level activities and personnel. Solves technical and managerial problems and is responsible for interacting with client management and technical personnel. Directs the completion of tasks within schedule and budget requirements.

Required Experience

A minimum of 2 years of experience is required. Experience should include work planning, budget control, schedule management, contract and subcontract management, and personnel management and supervision.

Required Education

A BS/BA or equivalent experience is required.

#### ASSOCIATE PROJECT MANAGER

Responsible for project performance and field services at a specific field project location. Provides direction of project-level activities and personnel. Solves technical and managerial problems and is responsible for interacting with client management and technical personnel. Responsible for the completion of tasks at specific field locations within schedule and budget requirements.

Required Experience

Experience should include work planning, budget control, schedule management, contract and subcontract management, and personnel management and supervision.

Required Education

A BS/BA or equivalent experience is required.

#### **SENIOR GEOLOGIST**

Responsibilities include developing geologic modeling parameters and interpreting geologic settings. Directs maintenance and updates of geological databases and models. Generates periodic resource reports to meet stakeholder and government requirements. Creates and validates interpreted geology cross-sections and maps to ensure consistency of interpretation. Provides quality control for incorporation of descriptive core logging information into the modeling.

Required Experience

A minimum of 4 years of experience in contaminated site investigation, remediation, or other specialized field of study is required.

Required Education

An MS/MA degree or equivalent experience is required.

#### **ENVIRONMENTAL SCIENTIST**

Duties include performing research, professional, and scientific work in any of the fields of natural or physical science. Responsible for conducting field investigations, remedial actions, and report preparation. Has working knowledge of environmental laws and regulations.

Required Experience

A minimum of 2 years of experience in contaminated site investigation, remediation, or other specialized field of study is required.

Required Education

A BS/BA degree or equivalent experience is required.

#### **DRILLER'S HELPER**

This position acts as an assistant to drillers. Duties will include assisting with drill rig operations and field tasks such as site layout, soil boring and sampling, obtaining water levels, and installing observation wells.

Required Experience

#### Required Experience

A minimum of 10 to 15 years of experience in all phases of construction is required. Must possess a complete and thorough understanding of all contractual specifications and drawings and be knowledgeable of QA/QC terminology.

#### Required Education

A BS degree in Construction Management, Engineering, Architecture, or demonstrated equivalent combination of education, training, and related experience is required.

#### FIELD SUPERVISOR

Ability to read and interpret construction plans and be intimately familiar with estimating, scheduling, bidding, change order, RFls, and effective client negotiation and follow-up experience. Working knowledge and skills related to permit requirements, application processes, and applicable codes. Excellent communication/problem-solving skills, strong sense of urgency, deadline- and detail-oriented, ability to effectively manage workforce with strong subcontractor and vendor relations, ability to work under pressure, track multiple projects, self-starter, able to work under minimum supervision.

Required Experience



A minimum of 5 years experience in all phases of construction is required. Complete and thorough understanding of all contractual specifications and drawings. Must be knowledgeable of QA/QC terminology, permitting, and applicable codes.
