Job Duties Description:

Provide life cycle systems engineering and integration (SE&I) expertise including supportability engineering, integrated logistics support (ILS), and sustaining engineering. Provide the support described above to the appropriate engineering efforts. Review and assess program and management documentation, and assist in developing documentation for system operations effectiveness (SOE), Integrated Logistics Support Plans (ILSPs), Logistics Support Analysis (LSA) and Logistics Support Analysis Records (LSARs), and maintenance trend analyses. Perform trade studies, operational availability, logistics support analysis, life cycle cost analysis, and risk analyses. Provide ILS training for engineering and management. Participate in milestone reviews and provide recommendations with supporting documentation.

Education Level Required:

Position requires a recognized subject matter expert with a BS degree in Aerospace Engineering or related field. Advanced degree is preferred. Minimum (30) thirty years experience required in the disciplines of Systems Engineering and ILS with specific experience in life cycle planning and support analyses for complex systems. Excellent written and verbal communication skills are required. Proficiency with Microsoft Office software applications is required. Position requires knowledge of applicable systems and vehicles, in-service operations, and flow processes desired.

Certification Requirements:

The person fulfilling the duties of this position should have credentials recognized by organizations such as the Council of Logistics Engineering Professionals (CLEP) and the International Society of Logistics (SOLE).

Service Contract Act: The Service Contract Act (SCA) is applicable to this contract as it applies to the entire PES Schedule and all services provided.
