If conducting NCQA Readiness Assessments or NCQA Mock Surveys, must have completed didactic and hands-on training approved by TMG on one or more sets of NCQA standards.
- Licensure:** Must have an unrestricted license to practice medicine or osteopathic medicine.

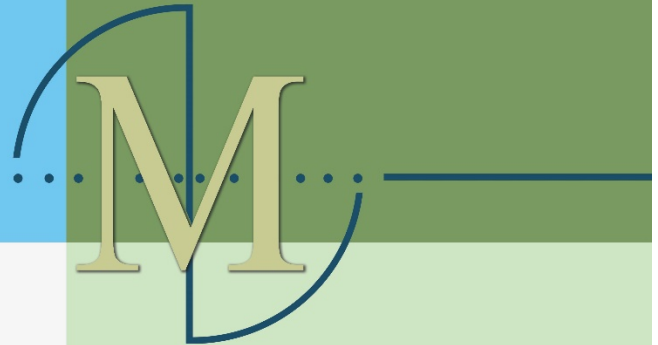
