The Ordering Process

When an agency determines that it desires to procure our services through this GSA Schedule, the program manager and the contracting officer of the ordering entity should collaborate in the process. For your convenience, Regis & Associates, PC has outlined the ordering process below. In comparison to the traditional contracting methods, this process is simple and can generally be accomplished within days. A summary of the ordering process is presented below:

- I. Service orders may be placed by the issuance of a delivery order agreement based on the fixed rates identified in our FSS contract. The ordering activity should prepare a statement of work that is consistent with the SINs identified in our catalog.
- II. When ordering services under this schedule, ordering activities need not seek further competition, synopsise the requirement, or make a separate determination of fair and reasonable pricing.

For orders under \$2,500, the ordering activity need only document:

- (a) The contractor selected
- (b) The item ordered; and
- (c) The total amount of the delivery order.

For orders over \$2,500, the ordering activity need only document:

- (a) Contact and/or review of the catalogs of three firms
- (b) The identity of the contractor and the item ordered
- (c) The total amount of the delivery order
- (d) The reason for the selection made; and
- (e) Any other documentation generally required by that agency's policies.

- III. When an agency anticipates the need for consulting services on a repetitive basis, but is uncertain of the quantities and timing of these intermittent services, that agency may establish a Blanket Purchase Agreement (BPA) with FSS contractors. Guidance on this process is provided under FAR Part 13, Subpart 13.202 (c)(3).
- IV. Under our schedule contract, an agency may place an order using one of three methods:
 - (a) An agency's contracting officer may issue a delivery order directly to Regis & Associates, PC.
 - (b) A GSA contracting officer may issue the delivery order upon receipt of a funding document from an agency's contracting officer.
 - (c) On-line access to contract ordering information, terms and conditions, up-to-date pricing, and the option to create an electronic delivery order is available through GSA *Advantage!*, a menu driven database system. **The INTERNET address for GSA *Advantage!* is: <http://www.gsa.gov>.**
