Hardigg Industries, Inc. warrants our rotationally molded containers and other listed products against defects in materials workmanship for a period of one (1) year from date of shipment. Hardigg shall, at our option, repair or replace any part or component which fails, during the warranty period, because of a defect in materials or workmanship. The government customer must obtain a return authorization number from Hardigg Customer Service prior to returning any containers. When Hardigg Customer Service authorizes the return of containers for correction of defects covered by warranty, the cost of transportation to the service location and the cost of return transportation to the customer's location will be borne by Hardigg. In the event that Hardigg determines the returned containers are not defective, within the terms of this warranty, government customer shall pay Hardigg all costs of handling, transportation and repairs at Hardigg's prevailing rates. It is understood that standard zinc-plated steel hardware will corrode in corrosive environments, and that such environments include, but are not limited to maritime environments. Hardigg recommends the choice of stainless steel hardware to achieve longer hardware life in corrosive environments.

Except for the foregoing express warranties, Hardigg disclaims, without limitation, all other warranties whether the same shall be expressed or implied.
