15. Warranty provision: All M.I.C.E. system parts and components are designed for sanitization and sterilization. All of Animal Care Systems, Inc. polycarbonate cages and polycarbonate accessories are warranted against defects in materials and workmanship for one (1) year or twenty five (25) 250° F. maximum temperature autoclave cycles from the date of purchase, whichever occurs first. Polysulfone cages and accessories are warranted against defects in materials and workmanship for two (2) years or fifty (50) 275° F. maximum temperature autoclave cycles from the date of purchase, whichever occurs first. All other parts are warranted for one (1) year from the date of purchase. This warranty is limited to replacement of defective parts if used in accordance with manufacturer-recommended

washing and autoclaving procedures. Sterilization of parts at temperature extremes higher than the manufacturer's recommended maximum will void the warranty for those parts.

Animal Care Systems, Inc. stands behind its products and is the original equipment manufacturer.

Due to the unique design of our systems (no electricity or moving parts), no on site maintenance or calibration is needed. Once proper installation is complete, only normal cleaning is required. Due to the modular nature of the design, repairs can usually be done on site with simple hand tools. If damage occurs during shipping or a product defect becomes apparent during the warranty period, Animal Care Systems will repair or replace the defective or damaged parts at its discretion. Repair will be done on site or at the factory, depending on the required work, at the discretion of Animal Care Systems, Inc. Replacement parts are available for quick shipment as described in the commercial delivery schedule 552.211-78. All replacement parts are new. Animal Care Systems does not use reconditioned parts.

If non-warranty repairs are required, Animal Care Systems, Inc. will negotiate with the individual ordering agency to resolve the problem by one or more of the following methods:

1. Provide repair instructions and ship the required parts upon receipt of purchase order.
2. Issue a "Return Authorization Number" (RA) for the return of the equipment to the factory. The individual ordering agency will, at its expense, pack and ship the damaged equipment to the factory for repair. Animal Care Systems will repair the equipment using the negotiated prices for parts. Parts not shown on the negotiated price list are priced at the standard "Domestic Retail Price". Labor will be charged at \$85.00 per hour with a one hour minimum and a five hour maximum per rack assembly. Animal Care Systems will provide shipping crates and supplies for the return. The individual ordering agency will pay the return freight charges.
3. Animal Care Systems will send a factory repair representative to the individual ordering agency site to repair the equipment.

The government will pay all travel expenses for mode of transportation, lodging, meals, and all incidentals relating to travel. Charges will be at the government rates and per diem. The individual ordering agency will negotiate any charges in excess of the government rates and per diem. Service shall be rendered as soon as possible after written notification is received and accepted by Animal Care Systems, Inc. All repair work will be performed during normal business hours, Monday through Friday.

Smaller installations that do not warrant on site installation or assistance can be handled using digital photography and email.

All rack systems sold by Animal Care Systems include technical training and support. Animal Care Systems provides written S.O.P.'s for using our equipment. In addition, at the discretion of Animal Care Systems, Inc., based on the size of the installation, we will provide the following at no additional charge:

1. Provide on site technical training.
2. Provide live on - line training via the Internet.
3. Provide training via other media.

Installation by Animal Care Systems:

At the discretion of Animal Care Systems, Inc., based on the size of the installation, we will send a factory representative to the individual ordering agency site (no fee) to supervise and assist in the installation of rack systems. This will include analysis of HVAC capabilities, air flow measurements on specific racks and installation of ductwork.

Installation by the Customer:

At the discretion of Animal Care Systems, Inc., based on the size of the installation, we will send a factory representative to the individual ordering agency site (no fee) to inspect the site, take measurements for ductwork and train site personnel on installation.
