26. NOTIFICATION REGARDING REGISTRATION IN CENTRAL CONTRACT REGISTRATION (CCR) DATABASE: American Furniture Rental is registered.

RESTOCKING CHARGE: Termination shall be authorized in writing prior to return of items. Early termination charges equal to two (2) months rental or 50% of the monthly rental times the number of months remaining, whichever is greater, shall apply. The Government shall be responsible to return products in the same condition as when they were first delivered.

CANCELLATION CHARGES: Cancellation of special order products shall be at "No Charge" prior to production. Once in production the contractor shall be entitled to collect cost incurred as of the time of cancellation. Once the rental agreement has been entered into, a cancellation request shall be deemed an early termination (See Restocking Charges).
