Cancellation Policy: No cost prior to production. After production has begun, only actual costs incurred will be billed to customer if merchandise cannot be resold within a reasonable length of time (6 months).

Lifetime Warranty: Dauphin North America warrants its Dauphin seating products to be free from defects in material and workmanship for as long as the original customer owns and uses the product under normal, single-shift office conditions. If a product is defective, and if written notice of the defect is given to Dauphin North America within the applicable warranty period, Dauphin at its option will either repair or replace the defective part or product with a comparable component or product. The Lifetime Warranty applies to all products, except as noted below:

This warranty does not apply to defects from normal wear and tear, accidents, negligence, abuse, shipment, handling, storage, or environmental conditions, nor does it apply to "Customer's Own Materials". Any modifications to our products made by the purchaser, purchaser's employees or agents, voids this warranty.

This warranty extends to all products shipped after August 1, 1994 which are used for normal office purposes and single shift service. All claims under this warranty must be made by the original purchaser within 30 days of alleged defect.

This warranty is the customer's sole remedy for product defect. No other expressed or implied warranty is provided. Dauphin North America is not responsible for any consequential, economic or incidental damages arising from any product defect.
