Job Title: Program Manager

Minimum/General Experience: The Project Manager (PM), also called Task Order Manager on larger task order contracts, shall have a minimum of seven years project experience, including three years management experience. The remainder may be specialized or general experience in project development from inception to implementation, with a demonstrated ability to provide guidance and direction in tasks similar to those identified in the Statement of Work.

Functional Responsibility: The PM shall direct, plan, organize, control and manage the program to ensure that all contractual obligations are fulfilled in an efficient and timely manner. The PM must be able to: manage multiple concurrent analysis and development tasks; serve as the Contractor's Point of Contact with the Government Contracting Officer and the Government Contracting Officer's Representative; formulate and enforce work standards, develop schedules, review work discrepancies, and communicate agency policies, purposes, and goals to subordinates; manage and control funds and resources; monitor the program budget at the top level, staff the program with qualified personnel, and ensure the schedule and deliverables are in compliance with the contract and the delivery orders; manage multiple concurrent analysis and development tasks

Minimum Education: The individual shall possess a Bachelor of Science (BS) degree or higher in Financial Management, Computer Science, Management Information Systems, Logistics, Management, or a related field. A master's degree in any of the above mentioned disciplines could be substituted for three (3) years experience.
