Exempt Status

Exempt employees include managers, executives, professional staff, technical staff, outside sales representatives, officers, directors, owners, and others whose duties and responsibilities "exempt" them from overtime-pay provisions of the Federal Fair Labor Standards Act (FLSA) and any applicable state laws.

Length of Continuous Service

All new employees are considered Introductory employees for the first 90 days worked (Introductory period). Your length of service record starts as of the first day of your employment, not the first day after the Introductory Period. The length of service can be broken only for one of the following reasons:

- Voluntary Quit
- Discharge
- Absence of three (3) consecutive workdays without a reasonable excuse satisfactory to ADSI
- Thirteen (13) weeks lapse between employment periods
- Failure to report on the first workday following expiration of an authorized leave of absence
- Failure to report for work when recalled from layoff, either by telephone, registered letter, or Federal Express delivery.
