SIN 653-1 RELOCATION SERVICES PACKAGE (653-1 A-D)

Appraised Value Sale

After the home is appraised and inspected Primacy Relocation provides the employee a guaranteed offer to purchase the home. The employee can then sell the home directly to Primacy Relocation and receive their equity under the statement of work and agency guidelines. Some agencies may require the employee to market the home for a period of time prior to initiation into this program or acceptance of the guaranteed offer, Employee may also market their property during the offer period prior to acceptance of the guaranteed offer in an attempt to generate an Amended Value Sale.

Amended Value Sale

While the employee is marketing the home they may receive a bona fide offer from a qualified buyer. Primacy Relocation may purchase the home from the employee based on that offer and close the sale with the outside buyer. An Amended Value Sale can occur prior to or subsequent to the guaranteed offer and results in a lower fee to the agency. For the employee to benefit from an Amended Value Sale, the sale must be presented prior to the employee's acceptance of the guaranteed Appraised Value offer.

SIN 653-4: ADDITIONAL SERVICES

Property Management (Formerly SIN 653-2)

Assists the employee on temporary or permanent assignment inside or outside the United States, who prefer to retain rather than sell their current home. The service allows the employee to focus on their new assignment while their departure residence is managed.

1. \$4200 fee for the first year
2. Monthly Fee: \$350/month for year two and every year thereafter
3. Broker Tenant Finding fee: Actual costs: not to exceed 12.0% of annual property rental value

Broker Fee Monthly: Actual cost: not to exceed \$2,400 per year

Training and Travel (Formerly SIN 653-6)

Training - Primacy will provide implementation training to agency employees for all services provided as outlined in the agency guidelines and the Statement of Work. Further, Primacy will provide training on demand at the agency's request. This may include remedial training on any service, training on new services, and special training for relocations issues and/or trends.

No Fee

Travel in Support of Training - When training is requested by the agency, Primacy reserves the right to request that the agency pay for the actual travel costs in accordance with Federal Travel Regulation (FTR) guidelines. This is for Primacy Personnel who travel in support of training services.

SIN 653-4 (D) Expense Management (Voucher Review and Payment)

Provides expense tracking services including employee counseling, expense reimbursement, auditing, tax calculations, reporting and employee year end tax information in compliance with the agency's guidelines and the FTR.

SIN 653-4 (E) Entitlement Counseling

SIN 653-4(G) Cost of Living Analysis

Provides a cost of living comparison between old duty station and new duty station. This can help the employee make a more informed decision when it comes to relocation.

SIN 653-4(H) Temporary Living Stand Alone Program

Provides assistance to the employee in locating suitable temporary accommodations in the new duty station.

\$350 per employee

SIN 653-4(I) Enhanced Rental Assistance

A half-day or full-day, detailed destination area tour that includes local real estate markets, commuting issues, area amenities and a community orientation.

One Half-Day Tour: \$350

One Full Day Tour: \$600

SIN 653-5 AGENCY CUSTOMIZATION SERVICES

SIN 653-5(A) Buyer Value Option (BVO)

Buyer Value Option (BVO)

This is a guaranteed home sale program that offers a Buyer Value Option. It is similar to SIN 653-1 with some eligibility and procedural differences. The employee’s home is purchased by Primacy Relocation based upon the terms and conditions of the offer received from an outside buyer. This program is a lower cost alternative to SIN 653-1 and is designed to offer the employee similar benefits to SIN 653-1 while reducing the cost for the agency. Home Marketing Assistance, Buyer Assistance and Mortgage Counseling are part of this offering.

Does not include Rental Assistance or Spousal Counseling.

SIN 653-5(C) Closing Services Only

Under this option, there is no guaranteed offer or home marketing assistance. Primacy Relocation will simply coordinate closing of the employee’s independently generated sale. Home sale expenses are subject to Relocation Income Tax Allowance (RITA).

Fixed Fee of 9.50% of the homes sales price

SIN 653-5(D) Stand-Alone Home Marketing Assistance

Under this option, there is no guaranteed offer. The focus is on providing home marketing assistance to help the employee generate an independent sale.

\$425.00 if the agency does not purchase a home sale program

SIN 653-5(E) Special Handling Transactions

Special Handling Transactions

Would apply to properties owned by an employee, which are otherwise eligible for Home Sale Services as defined in the statement of work or which are otherwise permitted under the FTR, but which are determined by Primacy Relocation and the agency to be either especially difficult to sell or where the property value is especially difficult to establish. Prior agreement between Primacy Relocation and the agency would be necessary before a property would be handled in this manner. For purposes other than fee, Special Handling Transactions will be handled in the same manner as for properties handled under the Home Sale Service (SIN 653-1 (A)) in accordance with the agency’s relocation program.

SIN 653-7 Move Management Services

\$375 per employee if CHAMP agreement is used.

Note: No fee if commercial agreement is used and if Primacy Relocation LLC is allowed by law, order, regulation or specific agreement (with the agency) to receive a booking commission or escrow fee from the carrier.

Full replacement valuation will be provided at \$5.00 per pound multiplied by weight of shipment up to \$100,000 at no charge.
