**Roadside Assistance:**

Penske employs 74 coordinators, 5 purchase order coordinators, 5 Supervisors, 1 analyst, and a director. We offer a nationwide serviced staffed 365 days a year and 24 hours a day. Each coordinator has a prerequisite knowledge of the transportation industry. They also have monthly training sessions with major Original Equipment Manufacturers. Penske has a database of 21,000 suppliers and 700 corporate locations who are rated and updated continuously. The rating is based upon response time and customer/driver feedback.

The assistance center is designed to ensure that any Penske customer has an available resource to assist in returning a disabled vehicle back to service in a professional, timely, and expedient manner. This is accomplished through the collaborative efforts of the SOS department, Penske's facilities, and/or independent road service providers.

**Driver Requirements:**

Vehicle shall not be operated by any person except customer and the following Authorized operators who must be 21 years of age, duly qualified and validly licensed to operate the vehicle, and have prior permission from the customer. Authorized operators for a commercial rental are: the employee, partner, executive officer, or regular employee, or additional authorized operator approved by Penske in writing. Authorized operators for a household rental are: customer and persons 18 or more years of age who are members of the immediate family of the customer and who permanently reside in the customer's household or are listed as additional operators on the rental agreement.

Drivers must show a minimum of two (2) forms of identification when picking up a rental truck. One form of identification must be a valid photo driver's license. Second form of identification can include: valid passport, federal and state ID cards, current visa, current military identification, birth certificate, association ID, employment-issued ID, major credit cards, health plan ID and store credit cards. If driver's license does not have a photo, you must provide another acceptable and current form of photo identification.
