**Shift Differentials:** Same as overtime

**Work Week:** Sunday – Saturday

**Overtime Rate(s):** 1.2x's normal hourly rate for all hours over 40 hours or per state and local labor laws.

**Holiday Rate(s):** Regular hourly rate

**On-Call Rate(s):**

\$8.00 per hour. The provider is to carry a beeper or cell phone and remain within 30 minutes/30 mile radius of the facility while in on-call status. Phone consultation is included.

**Call Back Rate(s):** If the provider is called back to the facility, the regular hourly rate applies. This rate begins once provider is physically at the facility and begins work. Minimum of one hour will be paid regardless if worked less.
