## **Minimum Qualifications of Professionals:**

### **621-027 - Registered Pharmacist / PharmD:**

#### **Education:**

All pharmacists working on behalf of AHS PharmStat will have earned either a Bachelor of Science (BS) or Doctor of Pharmacy (PharmD) degree and have graduated from an American Council of Pharmacy Education (ACPE) accredited pharmacy program. Graduates of foreign-based schools of pharmacy must have demonstrated equivalency to a U.S. school graduate as demonstrated by obtaining a Foreign Pharmacy Graduate Equivalency Certificate (FPGEC) from the National Association of Boards of Pharmacy (NABP).

#### **Licensure:**

All pharmacists working on behalf of AHS PharmStat are required to maintain an active license in a U.S. state or territory. Pharmacists are required to complete state-mandated continuing education and any other state-specific renewal requirements on or before expiration of their current license. Verification of current licensure is performed on a quarterly basis.

### **621-051 - Pharmacy Technician:**

#### **Education:**

All pharmacy technicians working on behalf of AHS PharmStat are required to have met the minimum education and training requirements in accordance with the laws of the state in which they practice. Certification by the Pharmacy Technician Certification Board (CPhT) or equivalent is preferred.

#### **Licensure:**

All pharmacy technicians working on behalf of AHS PharmStat are required to maintain registration/certification/licensure in accordance with the laws of the state in which they practice. Verification of current registration/certification/licensure is performed on a quarterly basis.
